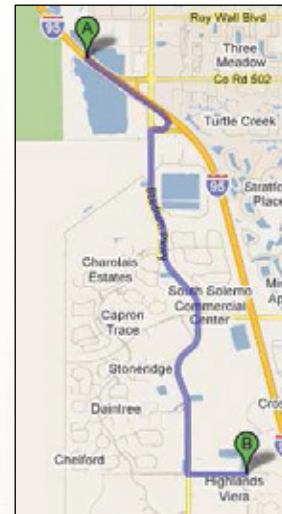
## Florida Department of Health In Brevard County – Viera Facility Conference Center

1. Head southeast on I-95 S toward Exit 195
2. Take exit 195 for Fiske Blvd/FL-519 toward Rockledge
3. Turn left onto S Fiske Blvd (417 ft)
4. Continue onto Stadium Pkwy (3.0 mi)
5. Turn left onto Judge Fran Jamieson Way
6. Destination will be on the right (0.5 mi)
7. Park at the back of the building

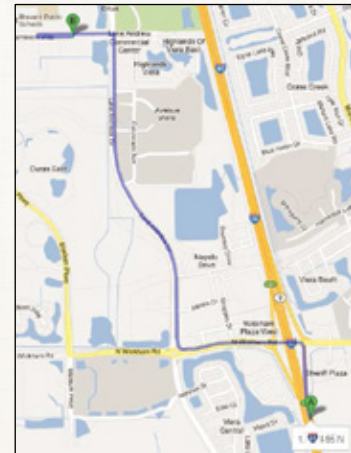

### From the South:

1. Head north on I-95 N toward Exit 191
2. Take exit 191 toward Brevard County 509/Satellite Beach/Patrick AFB
3. Keep left at the fork, follow signs for Wickham Road W (108 ft)
4. Turn left onto N Wickham Rd (0.4 mi)
5. Turn right onto Lake Andrews Dr (1.4 mi)
6. Turn left onto Judge Fran Jamieson Way (0.3 mi)
7. Destination will be on the left (0.1 mi)
8. Park at the back of the building
